Other taxes such as VAT and Council Tax do not qualify. Charities will reclaim 28p of tax on every £1 that you give up to 5 April 2008 and will reclaim 25p of tax on every £1 that you give on or after 6 April 2008. Please remember to notify us if at any time you want to cancel this declaration, change your name or address or no longer pay sufficient tax on your income and/or capital gains.
